Policy Statement

Any regular faculty of the college is entitled for attending Conference/Seminar/FDPs/Workshops/Orientation Programs at National Level once in a financial year on Institutional expenses subject to the following prerequisites:

- 1. The event should be organised by Government bodies like UGC-MHRD cells of Universities, ATAL, AICTE, NPTEL etc. and should be in public interest.
- 2. The financial support is subjected to availability of funds in the institution.
- 3. TA and DA will not be granted by the institution but the faculty member shall be entitled for Duty leave during the tenure of the program.
- 4. The faculty has to provide all necessary documentary proofs like, Registration receipts, Certificate of completion etc. for availing the financial support.
- 5. The financial aid provided will be in the form of a reimbursement only and will not be provided during registration processes.
